Parent/Guardians Please go over these expectations with your student(s)

	Students are expected to bring a fully charged Chromebook to school every day and bring their Chromebook to all classes unless specifically advised not to do so by their teacher.
	If a student does not bring his/her Chromebook to school, <u>a loaner will not be issued</u> and the student might not be able to participate in or complete their classrooms assignments.
	Students must charge their Chromebook at home every evening. They must be brought to school each day with a full charge. No loaner chargers will be issued.
	Students may alter the desktop background of their Chromebook with school-appropriate media.
ū	Students will log into their Chromebooks using their school issued Google Account. All other personal Google profiles added will be removed.
	Students should never share their account passwords with others, except for their parents/guardians.
	No other family members are allowed to use your assigned Chromebook, NO Exceptions .
	Students are encouraged to use their Chromebooks at home and other locations outside of school. A Wi-Fi Internet
	connection will be required for the majority of Chromebook use; however, some applications can be used while not connected to the Internet.
	Students are bound by the <u>Edmonds School District Administrative Procedure 7396 R-1 Electronic Information Systems</u> (Network) Acceptable Use Procedures and Guidelines. See ESD website for full document.
	Students should not alter the Operating systems or other applications installed. Students are not permitted to download other software applications without prior consent and doing so could result in disciplinary action.
	The majority of student work will be stored in Internet/cloud based applications (Google Drive, Google Classroom, Canvas, etc.) and can be accessed from any computer with an Internet connection and most mobile Internet devices. Some files may be stored on the Chromebooks hard drive. The school district will not be responsible for the loss of any student work.
	Students do not need to manually update their Chromebooks. However, students should reboot once a month to ensure updates take effect.
	There is no need for additional virus protection, as this is built into Chrome Operating System. Students are allowed to install Chrome web apps from the Chrome Web Store that have been approved by the school district.

	Chromebooks that are broken or fail to operate properly must be taken to the Tech Support Area which is located in the MMS Library.
	Chromebooks should never be taken to an outside computer service for any type of repairs or maintenance, this includes friends and or family who are tech savvy.
	No food or drink should be next to Chromebooks.
_	Chromebooks must remain free of any writing, drawings, stickers, paint, and labels that are not applied by Tech Staff.
	A \$5.00 fine will be placed on your student's account for any labels that are removed (District Asset Tags and Name Labels). If the label(s) are coming off due to wear and tear, please come down to the CB office to get a replacement at no cost.
	The Chromebook screen can be damaged if subjected to heavy objects, rough treatment, some cleaning solvents, and other liquids.
	Loaner Chromebook are issued to students when their assigned Chromebook is in repair with the Para Tech.
	A student borrowing a Chromebook will be liable and responsible for any/all damage to or the loss of the loaned device.
	At the end of the school year, students will turn in their Chromebooks. If a student transfers out of or withdrawal from school, he/she must turn in their Chromebook in good working condition. Damages and loss will be checked against the school year usage and may incur fines.
	Failure to turn in your assigned Chromebook in good working condition may result in the student being charged the full replacement cost. The District may also file a report or stolen property with the local law enforcement agency.
